Judge Orders Trump Administration to Continue Receiving DACA Renewal Applications

A federal district judge in San Francisco blocked Trumps decision to end the Deferred Action for Childhood Arrivals (DACA) program and ordered the administration to continue receiving DACA renewal applications. The order applies to those with DACA whose permit expired after September 5, those who did not renew by October 5 or those who were ineligible because their status will expire after March 5, 2018. The order does not apply to new applications.



The United States Citizenship and Immigration Services (USCIS) is now accepting renewal applications. DACA recipients who are looking to renew can also get a scholarship from MAF to cover the \$495 application fee.

Female Leaders Hope to 'Inspire, Empower' Women with March

Millions of women will band together next week in cities across the nation in a monumental march for female empowerment as they plan to flex their political might in Kern County.

Last year, millions rallied following President Donald Trump's inauguration, with many participants marching in opposition to statements he made that some said degraded women. They marched in major cities, including Cincinnati, New York, Atlanta and Washington, D.C.



Many Kern County women took buses to Los Angeles and participated in that march. Kimberly Kirchmer, a substitute teacher and local community activist, was among them.

She contacted event organizers in L.A. this year to ask about again coordinating buses to and from the valley. They turned her down, and instead challenged her to organize an event of her own.

The Women's March Kern County will gather at Central Park in Downtown Bakersfield at 10 a.m.

Kern High School District to Host Forum on School Discipline and Climate

The Kern High School District will this month host its second community forum on school climate, a condition of a settlement agreement it entered into after parents, students and advocacy groups alleged it engaged in a years-long pattern of discriminatory discipline practices.

While the district denied any "intentional systemic racist student discipline practices," it came to a

settlement agreement with plaintiffs in July 2017 that included hosting two community forums each school year detailing the district's rates of suspension, expulsion, and involuntary transfers.

It's important for parents to attend the forum so they can learn about how students are being disciplined in KHSD schools, said Catherine Retana, a lawyer with California Rural Legal Assistance, which took part in the suit against KHSD.

The community forums are a step towards more accountability and transparency between the district and families, Retana said.

The Community Forum runs from 6 to 8 p.m. Jan. 30 at the KHSD Board Room, 5801 Sundale Ave. The district will teleconference the forum from Arvin High School, Shafter High School, and Kern Valley High School.

ACLU Report Exposes Excessive Force and Lack of Accountability in Local Law Enforcement Agencies

Almost two months after the American Civil Liberties Union of Southern California slammed Kern County law enforcement in a report alleging widespread civil rights abuses, it's unclear what steps either of the two largest policing agencies have taken to address deficiencies highlighted in the agency's report.

Bakersfield Police Department Sgt. Ryan Kroeker wouldn't tell South Kern Sol whether the department has reviewed the ACLU's 24 page report - which paints a scathing picture of Kern County law agencies run amok - or if it has sparked any internal review processes outside of an ongoing California Department of Justice probe into alleged civil rights violations launched in 2016 by former California Attorney General Kamala Harris.

Instead, Kroeker referred South Kern Sol to a two-month old press release reiterating that BPD Chief Lyle Martin would not address the report, and that the DOJ "has the sole authority to make comments regarding the investigation."
